Applications are invited on plain paper for filling up temporary position of Project Assistant-II (Category I) and RA on contract basis, as per the following details:

Title of the Project :	Development of sustainable waste management technologies for chemical and allied industries
Minimum prescribed educational Qualifications/experience ⁽²⁾	(1) For PA-II B.E. (Chem)/ B. Tech. with minimum 55% marks OR ME/M.Tech (Chem)- PA-III- with or without experience (2) for RA, Ph D Eng./Sci., preferably in the area of wastewater treatment/ adsorption/separations
Preference	Candidates with computer knowledge and with experience (for PA-II) will be preferred.
Job requirement	The project involves development of pollution control methodologies for chemical and allied industries, specifically pertaining to petroleum industry and distillery wastewater treatment. The work would involve laboratory and pilot plant experiments specifically pertaining to hydrodynamic cavitation and adsorptive separations apart from other separation processes. It would also involve process integration studies mainly using cavitation, adsorptive separation-reaction approach and development of modified adsorbent/ new materials/ application of nano-materials/material coating, characterization of materials and applications for removal of sulphur components including refractory sulphur compounds from transportation fuels.
